
CDL Entry Level Driver Training

ELDT training is broken down into two different components – theory training and then behind-the-wheel training.

During this presentation we will discuss what the ELDT training requirements are, who can provide the training and the training provider registry and what this training entails.

Barb Aude, Director of Training and Safety with the Nebraska Trucking Association since 2018, assists Nebraska Trucking Association members with federal motor carrier safety regulations often referred to as DOT regulations, as well as the education of Nebraska laws concerning commercial motor vehicles.



As the Director of training and safety, Barb serves as a liaison between the trucking industry and State and Federal agencies. Barb travels the state conducting training and onsite instructional safety meetings. One of the more unique parts of her job is the personalized safety consultations which are similar to mock DOT audits. These are tailored to each carrier's specific operation.

Prior to her association work, Barb served 32 years with the Nebraska State Patrol as a Trooper and as an Investigator in the Nebraska State Patrol Carrier Enforcement Division.

Barb said the trucking industry brings a new challenge each day. It's a highly regulated industry, and with education and training we can make our roads safer for both our commercial vehicle drivers and the motoring public.
